# NCDEA Board Strengthens Partnerships at the 2025 NASCA & NWC Joint Meeting

The NCDEA Board participated in the 2025 Joint Annual Meeting of the National Association of State Conservation Agencies (NASCA) and the National Watershed Coalition (NWC), held October 26–29 in Fort Worth, Texas, at the Radisson Fort Worth North at Fossil Creek. This important gathering convened conservation leaders, state agency directors, watershed sponsors, and partners to discuss advancing soil, water, and watershed stewardship nationwide.

The event highlighted Texas's innovative approaches to watershed management and flood control, with field tours showcasing local structures focused on maintenance, rehabilitation, and resilience. Sessions included parallel NASCA and NWC tracks, state idea-sharing, and joint discussions on policy and innovation.

## **NCDEA's Key Engagements**

NCDEA President Melissa Higbee and Executive Director Tim Riley, with Vice President Sarah Tunge in attendance, delivered a joint report to the NASCA Board of Directors. They updated members on NCDEA's priorities in employee training, regional support, and advocacy for conservation district staff.

The meeting also featured a dedicated session with National Conservation Partnership (NCP) leaders from NACD, NARCDC, NASCA, and NCDEA, aligning on unified national strategies.

Additionally, the NCP Leadership Team met to further the National Conservation Planning Partnership's goals of reinvigorating conservation planning through strong collaborations.

Notably, the meeting's success demonstrated the remarkable resilience of our conservation partnerships. Held amid the ongoing extended federal government shutdown that disrupted federal conservation delivery nationwide, the gathering proceeded productively, underscoring the dedication of state, local, and partner entities in maintaining momentum for on-the-ground work.

**These interactions reaffirm NCDEA's role in connecting district employees to broader national efforts.**

## NCDEA Leadership Engages with USDA-NRCS & National Partners in Washington, D.C.

In early December 2025, NCDEA President Melissa Higbee, Vice President Sarah Tunge, and Executive Director Tim Riley traveled to Washington, D.C., for a series of engagements focused on advancing conservation district employees' priorities.

On December 8, the team met with USDA-NRCS leadership to address critical challenges facing conservation delivery, particularly in the wake of the extended federal government shutdown. Our priorities were shaped by direct input and inquiries gathered through the NCDEA Board's communications with district



employees nationwide. Key discussions focused on strengthening the National Conservation Planning Partnership and increasing interstate consistency of Job Approval Authority for district employees. Additionally, the team advocated for the future stability of district agreements, continued support for non-funded workspace-sharing arrangements, and the universal adoption of the national Portal system to ensure consistent grant reporting and billing.

In addition, the same NCDEA leadership group engaged with national conservation partners during meetings with both NASCA, and the NACD Executive Board and staff. These collaborative conversations reinforced unified strategies across the partnership and emphasized the vital role district employees play in maintaining momentum for on-the-ground conservation.



Advocacy visits like these ensure that the perspectives and needs of frontline conservation professionals are directly represented at the national level. Thank you to everyone from our partner organizations for the productive dialogue, and to our leadership team for their dedicated representation of NCDEA members nationwide.

# Reflections on the 2025 SECDEA Annual Conference

NCDEA had a strong presence at the 2025 Southeast Conservation District Employees Association (SECDEA) Annual Conference in Pigeon Forge, Tennessee (November 3–5), with Secretary Kayleigh Evans, Southeast Region Director Kelly Snoddy, Southeast Region Alternate Penny Warwick, and Executive Director Tim Riley attending.

Themed "Unmasking the Success of Southeast Conservation," this energizing event brought together dedicated conservation professionals from across the region for learning, sharing, and celebration. Under the strong leadership of SECDEA President Kelly Snoddy and the SECDEA Governing Board, the conference delivered two packed days of valuable sessions - from NACD



grant panels and hands-on trainings like Canva Creations and Conservation Jenga, to insightful topics on Farm-to-Table, Envirothon, and innovative programs like North Carolina's Book Barn. State Share Fairs highlighted impressive accomplishments from across the region, while partner updates from NACD, TACD, and others reinforced our shared commitment.

Tim Riley provided the NCDEA partner update, sharing our ongoing work to strengthen regions, deliver free training through webinars and Convene sessions, publicly launch the new NCDEA Connections newsletter for the first time, and advance the National Conservation Planning Partnership (NCP). He also had the privilege of presenting the American Flag during the opening flag ceremony and installing the newly elected SECDEA officers in service to the SECDEA Governing Board.

Events like this remind us how vital regional collaboration is to our national voice. Thank you to SECDEA for another inspiring conference that equipped us all to continue advancing conservation across the Southeast region and beyond.

## National Conservation Planning Partnership (NCP)

At NCDEA, we understand the effort it takes to keep the spirit of conservation alive. As a proud partner of the NCP, we have played a vital role in its accomplishments over the last decade and the exciting, renewed strategic direction that starts in 2026.

To that end, the NCP Leadership Team convened during the NASCA and NWC Joint Meeting in Fort Worth, where a key focus was the exciting new Conservation Planning Training Pilot program, detailed at [www.ncpp.info/pilot-training](http://www.ncpp.info/pilot-training). This innovative hybrid initiative streamlines certification for conservation planners by combining required courses - such as



Conservation Planning Part 2 and Soil Health and Sustainability - into a coordinated experience with online pre-work and hands-on in-person training. The pilot aims to provide step-by-step support, gather partner feedback, and develop a scalable nationwide model to build greater capacity for quality planning.

The first session is scheduled for February 15–19, 2026, in San Antonio, Texas, in conjunction with the NACD Annual Meeting (with additional pilots planned in other locations).

Sign-up for the San Antonio training was a huge success, with application numbers far exceeding expectations and capacity—demonstrating strong demand for this vital professional development opportunity. Despite the challenges of the ongoing federal government shutdown at the time of the meeting, the non-federal partners of NCPP (including NACD, NARCDC, NASCA, and NCDEA) reaffirmed their strong commitment to advancing NCPP efforts. This dedication highlights the resilience and shared resolve of our partnership to support planner development and ensure seamless conservation delivery.

In addition, the team advanced new resources and tools NCPP will launch to support your work - and we want to ensure you're among the first to access them.

# Spotlight on Innovative District Programming: Eagle Conservation District's Noxious Weed Initiative

In our ongoing commitment to sharing successful and replicable programs from across the country, we're excited to highlight a recent NCDEA professional development webinar featuring the Eagle County Conservation District (ECCD) in Colorado.

The October 2025 webinar, now available on [NCDEA's YouTube page](#), showcased ECCD's unique and highly effective noxious weed cost-share program. Presented by Program Manager Allegra Waterman-Snow and District Conservation Technician Greg Welsh, the session offered valuable insights into building a sustainable, community-focused initiative that combines financial incentives with essential technical assistance.

➤ Key takeaways from the presentation include:

- **Program Evolution and Growth:** Reactivated in 2021 after years of limited activity, ECCD transformed a modest \$5,000 annual grant into a robust program through strategic partnerships with Eagle County, grant funding (including a \$160,000 America the Beautiful Challenge award), and voter-approved mill levy support generating over \$700,000 annually.
- **Focus on Technical Assistance:** While offering generous 75% cost-share reimbursements (up to \$2,250 per landowner), the program prioritizes education and planning. Staff conduct site visits, create customized management plans using tools like ArcGIS and Survey123, and provide species-specific guidance on biological, cultural, mechanical, and chemical controls—plus revegetation recommendations.
- **Community Impact:** In 2024–2025, the program engaged dozens of landowners and HOAs, evaluating thousands of acres. Many participants seek guidance more than funding, highlighting how knowledge builds long-term stewardship.
- **Sustainability Strategies:** Emphasis on permanent partnerships, grant leveraging, and stable local funding ensures ongoing capacity without relying solely on temporary sources.

As Allegra noted, "The technical assistance portion tends to be more important than the financial assistance," a reminder that empowering landowners with knowledge often yields the greatest lasting results.
